The above founders have decided to create a Public Charitable Trust for the cause of Education and other Charitable purpose and in pursuit thereof have declared initial sum of Rs. 100/- (Rupees one hundred only) each as belonging to the trust. All the members of the Trust have equal rights and powers. All the trustees are life members. All Trust members have hereditary rights. Male heir should be given preference and if no male heir, the female heir can be accepted as a Trust member and if a Trustee has no sons and daughters, he/she may appoint any one of his/her relatives as his/her heir and he or she shall be accepted as a member of the Trust. The Founder of the Trust shall be Trustees of the trust.

1. The name of the Trust shall be Vani Vidyalaya Educational and Charitable Trust.
2. The Office of the Trust shall be at Sankarai Main Road, Elanthakuttai (Post) Veppalai, Pallipalayam, Namakkal (Dist). Or such other place or places as may be decided by the trustees from time to time.
3. The following shall be objects of the Trust.
 1. To provide School Education - Basic, Elementary, Secondary, Higher-Secondary including vocational education work experience etc.
 2. To provide Collegiate Education, Pro-Degree course, Integrated Course, Post Graduate Course and Doctoral Programmes in Arts, Science, Medicine, Para Medical, Commerce, Social Sciences, Veterinary Science, Humanities, Social Work Education, Integrated rural Development etc.,



3. To provide Adult and Continuing Education, Non Formal Education in all fields, careers and professions in several modes including short term courses, evening colleges and part time courses both at under graduate, post graduate and doctorate levels.
4. To provide technical education programmes through full time and part time courses at the Diploma, Degree, Post Graduate and doctoral levels in all branches, specialties, disciplines of Engineering, Architecture, Computer, Applied Science and Technology including Management Science, Sandwich Courses, evening Courses, short term and non-formal courses and continuing education programmes.
5. To provide industrial education, research and training at all levels, viz, Draftsman, Technician, Professional and Post Graduate levels, through part professional and sandwich courses, training before and after education and during vacations in various skills, arts and crafts as well as various trades and branches of Engineering, Technology, Industry, Commerce and Applied Arts also including all other branches of education, skills and knowledge as set out, Agriculture, Horticulture, Sericulture, Forestry, Textiles, Industrial Design, Home Science, Dietetics and Nutrition etc.
6. To provide ample opportunities for integrating the education and training with the needs of Socioeconomic development, Social Service, Community service, Rural development, Urban development and such other new disciplines and specialties through the establishment of Research and Training Cum Production Centres.
7. To provide Teacher Training Programmes, Teacher Services and Courses for general teaching, Collegiate teaching and for teaching in technical and Technological Institutions.
8. To provide job oriented education, training and work experience programmes including Earn while you learn schemes and such education and training so as to develop self employment and entrepreneurship.
9. To maintain, develop, improve and extend facilities available in the various institutions under the Trust and to introduce additional facilities as may be required for the purpose of education, training, research and development in the various fields such as Education, Arts, Science, Medicine, Engineering, Technology, Textiles, Dietetics and Nutrition, Management Sciences, Veterinary Sciences, Industrial and Agricultural Productivity, Products and Process and to provide consultancy and technical assistances.
10. To accept the Autonomous status to any of the Institutions, Deemed University status as and when the University Grants Commission, and other competent authorities accord.

11. To provide for the dissemination of literary, cultural, Scientific and Technical knowledge through educational and literary surveys, Publication of journals, Magazines, Periodicals, Newspapers, Books, Pamphlets in the regional language (Tamil) as well as in English and Hindi and to establish necessary facilities for printing and publication.
12. To undertake and promote research and development activities in Industry, trade and commerce through the establishment of research and development centre and by extending technical and financial assistance to the existing R & D Centres functioning in industries and educational institutions.
13. To provide free medical aid to the needy and deserving by establishing, maintaining and conducting primary health centres, maternity and child welfare centres and hospitals.
14. To encourage and promote medical education, research and training including veterinary education and research and such other branches of medical and veterinary education through the establishment of Advanced Research Cum Training Centres / Institutions.
15. To establish maintain, improve and extend the hostel facilities for the benefit of the students of the Institutions.
16. For the furtherance of the objects enumerated above, to maintain liaison with professional institutions and educational and training bodies in various parts of India.
17. To provide fees, books, equipments, free ships, and /or scholarships to deserving students.
18. To render assistance to poor patients by providing medicines etc provisions of health care, preventive medical services (including dental services)
19. To render financial assistance to the poor and the disadvantaged.
20. To render assistance, both directly and through established social welfare organisation, for appropriate literacy, educational and vocational training programmes that will help rehabilitate women in distress, especially widows without any means of support and those neglected and ill-treated by their husbands or other members of the family and promote their vocational skills and self-reliance.
21. To educate or assist in the education of children and for this purpose take all steps for the formation of appropriate forum and institutions and to acquire lands and buildings or develop places dedicated to educational and cultural progress of children.
22. To open orphanages and other such institutions to rehabilitate orphans, destitutes and distressed.

- 23. To acquire/ Take over /merge all the assets and liabilities of any business/societies and to run the same for the welfare of public.
- 24. The benefits of the Trust are open to all irrespective of caste, religion, race or sex.
- 25. The objects mentioned supra shall be independent of each other and the Board of Trustees hereinafter constituted from time to time, apply the funds of the trust to carry out all or any of the aforesaid objects of the trust as it may deem fit to their absolute discretion.

BOARD OF TRUSTEES SHALL HAVE THE FOLLOWING POWERS:

- 1. All the properties, funds, and assets of the trust shall vest in the Board of trustees and they shall be in complete management of the affairs of the trust.
- 2. To purchase land and buildings and maintain and keep up lands, buildings, equipment and materials and to sell, mortgage or dispose of all or any of the same as the trustees may think fit.
- 3. To execute, become party to, sign acknowledge, perfect and register all deeds, agreements and to give effectual discharge on behalf of the trust.
- 4. To borrow from time to time such sums of moneys for such period on such terms with or without security as the trustees may think fit.
- 5. To draw, make accept, endorse, deposit, negotiate, execute and issue promissory notes, bills of exchange, hundies, cheques, Government and other negotiable instruments.
- 6. To initiate, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claims or disputes, by or against the trust or trustees or against its officers or employees concerning the affairs of the trust and to sign and verify vakalaths, plaints statements, execution, petitions, affidavits and other proceedings.
- 7. To open and close accounts with banks to operate upon any such accounts to pay and draw money from such accounts and otherwise deal with the same and the powers in this behalf may be exercised by the secretary or by any other trustees empowered by a resolution of the trustees in a meeting held under the president ship of the chairman.
- 8. To invest the funds of the trust only in any investments authorised under the provisions of the Income Tax Act and other Direct Tax Acts which will enable the trust to avail the exemption available thereunder.
- 9. The trustees are authorised to borrow moneys for the purpose of the Trust from Banks, financial institutions and others with or without security and in respect of any other assets both moveable and immovable belonging to trust and execute under the deed of agreement or deed or mortgage for the purpose of offering the assets of the trust as security in respect of such borrowings.

10. The trustees are entitled to sell, lease, mortgage or dispose of such assets and immovable properties as may be found necessary in this behalf on approval of the trust board.
11. The trustees are authorised to acquire by purchase or by lease, land, buildings agricultural lands and other properties for the purpose of the objects of the trust. The trustees are authorised to construct on trust land or lease land, superstructure for the purpose of the object of the trust.
12. The trustees are entitled to make rules for the purposes of the objects of the trust, but such rules shall not be against the objects of the trust as state above. Any amendment to any clause of this trust deed shall be carried out only with the approval of the board of trustees, subject to the provisions of law.

ISPOFACTO

A. Trustee shall cease to hold the office

- a) On his death
- b) On his resignation
- c) On his becoming insane/insane
- d) On his being expelled by the Board of trustees for his acting or having acted against the interests of the trust by a majority vote, provided such trustee has been given a reasonable opportunity of explaining his conduct to the board of trustees.

Any trustee retiring, resigning or being removed from office shall continue to be liable to the trust for all his actions during the period of his office.

THE POWERS AND FUNCTIONS OF THE GOVERNING COUNCIL

1. There shall be a Governing Council to look after the affairs of the trust and to take decisions on all matters and to formulate ways and means to carry out the objects of the trust. The total number of members of the governing council shall be three members.
2. The Governing Council shall be elected by the trustees and is presently constituted as follows:

1. Chairman	:	Pandit Ashok Bhattarai
2. Secretary	:	N. Prakash
3. Treasurer	:	S. Senthil Kumar
3. The first Governing Council elected during April 2001 shall hold office for 6 years. The subsequent Governing Council shall hold office for three years from the date of assuming office.
4. The Governing Council meeting shall be convened at least once in a month. Ordinarily a seven days notice is required for convening this Governing Council meeting. At times of emergency, it can be convened within forty eight hours.

5. The quorum for the Governing Council meeting is two. If within half an hour from the time appointed for the meeting, a quorum is not present, the meeting is adjourned 48 hours and the members present in such an adjourned meeting shall be the quorum.
6. All decisions of the Governing Council meeting shall be decided by a simple majority of the members present.
7. The Governing Council members will look after the administrative works regarding the school of the trust and any such institutions to be instituted thereafter for the promotion of all other objects of the trust.
8. The Governing Council shall be entitled to the management of the affairs of the trust with respect to the maintenance and promotion of community halls, charitable educational institutions, hospitals, hostels, boarding houses, workshops and other objects of the trust.
9. The Governing Council shall have the control over the staffs working in all the institutions and establishments run by the trust.
10. The Governing Council may vest the authority to such a trustee or trustees as may be required for the efficient execution of its duties.
11. No act of the Governing Council or exercise of the powers hereby specifically conferred shall be interfered with by the trustee except on the ground of its manifest impropriety or on the ground that it is a gross breach of the duty on the part of the Governing Council.
12. The Governing Council shall have the custody and control of all the documents, accounts and other papers relating to the trust and the same shall be open to inspection by any trustee on giving reasonable notice to it.
13. The Governing Council shall have the authority
 - a. To carry out the resolutions of the Board of Trustees.
 - b. To receive and pay out moneys.
 - c. To sign papers, receipts and documents.
 - d. To delegate the power to draw, endorse, accept and negotiate cheques and bills through jointly with the Secretary and Treasurer.
 - e. To delegate the power to endorse or accept and negotiate promissory notes and bills or other negotiable instruments, Government or other securities, papers or bonds through jointly with the Secretary and Treasurer.
 - f. To lease out subject to confirmation by all the Trustees for a period not exceeding three years, lands and movable and immovable properties of the trust.
 - g. To initiate, prosecute and defend, compromise, refer to arbitration or abandon legal proceedings with the concurrence of all the Trustees.
 - h. To delegate the power to execute all other documents through its secretary on behalf of the trustees not specifically mentioned above.

14. Funds of the trust shall be deposited in current, savings or any other accounts in any Nationalised Bank authorised by the Governing Council and opened in the name of the trust and operated jointly with the treasurer and the secretary.
15. No act of the Governing Council which requires previous sanctions of the Board of trustees shall be valid, even if the said act is subsequently ratified by the Board of Trustees.
16. The Governing Council may reimburse the amount expended on behalf of the trust by any trustee from out of the trust funds.

CHAIRMAN

1. The Chairman of the Governing Council is also the Chairman of the Trust.
2. The Chairman of the Trust shall preside over the Governing Council meeting and General body meetings of the trust and any other sub-committees formed to fulfil the objects of the trust.
3. In case of the absence of the Chairman, the Secretary or any of the office bearers whoever is present or any member of the Governing Council Present at the time of meeting, be elected as chairman for the particular meeting.
4. The Chairman of the meeting shall have casting vote in case of dispute of decision.


THE POWERS OF THE SECRETARY

2. Prepare the agenda for both meetings in consultation with the Chairman.
3. Maintain minutes of the Governing Council and Board of Trustees meetings.
4. Implement resolutions passed at the said Board of Trustees Meetings.


THE POWERS OF THE TREASURER

1. The Treasurer has the power to deal with all cash dealings, bank transactions and accounts of the Trust and has the joint power for signing the cheques along with secretary.
2. He can make payments on behalf of the trust upto Rs. 5,000/- under extraordinary circumstances and should get the ratification from the next immediate Governing Council Meetings.
3. For incurring Expenditure more than Rs. 5,000/- a formal approval from Governing Council should be obtained.
4. He should deposit the funds, donations, fees and all other incomes collected for and on behalf of the trust into the Nationalised Bank/ Banks authorised by Governing Council by next working day.

- 5. He should keep, maintain proper accounts of the trust.
- 6. He should prepare annual financial statements, Budgets and income and expenditure statements in consultation with the secretary.

ELECTIONS

- 1. Election to the three posts of the Governing Council should be held once in three years, except the first one set-up during April '2001 which can hold the post for six year.
- 2. Thirty days prior to the expiry of the time of the Governing Council posts, the Chairman and the Secretary should send circular regarding it to all the members of the trust and notification to be issued for fresh elections of the same post. All the trustees have the voting rights.
- 3. If any vacancy falls with respect to any Governing Council members, it may be filled up by co-optation from among the trustees. Such co-opted member shall hold office until the ensuing election of the Governing Council.
- 4. The Board of trustees may form necessary sub-committee to look after any of its affairs as it may deem fit.
- 5. The trustees shall conform to the provisions of the Indian Trust Act in all matters not expressly provided for herein but in case of difficulty or doubt arises in any matter in relation to the management or administration of the trust or any matters falling hereunder, may be referred to arbitration. In case need arises, the trust have the right to go to court for redress or remedy.
- 6. The majority of the trustees present in the General Body meeting may, (from time to time) make and prescribe rules and by-laws, regulating their management and carrying out the objects of the Trust; investment of the trust funds and the realisation thereof and all other matter incident to the working of the trust and from time to time modify alter or amend such by-laws, provided that no such by-law or amendment should contravene the objects of the trust. After such resolution is carried over in the General Body meeting, the majority of the trustees may authorise the Governing Council members to execute such amendments at the registrar office.
- 7. The total number of trustees can be increased by the Board of Trustees, provided three fourth of the total number of trustees enrolled pass such resolution.
- 8. The beneficiaries under the trust shall be deserving person irrespective of caste, creed, sex or religion.
- 9. The income and funds of the trust shall be solely utilised towards the objects and no portion of the same shall be utilised for payment of trustees in any manner.



10. The majority of the trustees present during the General body Meeting shall have the powers to invest in movables and immovable, deal with them in any manner or dispose of any such movables and immovable in the interest of the trust. The trust however does not own any immovable property at present other than the initial investment of Rs. 100/- (Rupees one hundred only.)

ACCOUNTS

The Trust shall maintain regular accounts of all its transactions showing clearly the receipts and expenditure. All the expenses of the trust shall be properly vouched. The accounts of the trust shall be closed on 31st March every year and audited by a qualified Chartered Accounts.

STATUORY OBLIGATIONS

- a. The trust shall invest its trust funds only in securities permitted under the provisions of section 11 and 13 of the Income Tax Act 1961 as amended from time to time. No investment shall be made by the trust in any security or in any manner which shall render it ineligible for exemption under the provisions of the Income Tax Act in respect of donations received by it or in respect of donations received by it or in respect of income earned by it under the provisions of section 11 or any other provisions of the Income Tax Act.
- b. It is specifically stated that the trust shall not make any investment or enter into any transaction with the founders of the trust which shall render the trust ineligible for exemption under the provisions of the income tax act or bring it within the mischief of the Income Tax Act providing the disallowance of exemption from tax or its income and of the donations received by it.

INDEMNITY:

The trustees shall at all times stand indemnified in respect of any bonafide act, suffered or omitted to be done in respect of matter relating to the trust.

The rules herein contained may be altered amended, modified or cancelled in any manner by a resolution duly passed by 2/3 majority of the trustees at the meeting of the Board of Trustees, convened for the aforesaid purpose.

MEETINGS:

MEETING OF THE BOARD OF TRUSTEES

1. The board of Trustees shall ordinarily meet once in a year
2. The period between two Board Trustees meeting should not exceed 15 months.
3. The meeting shall be convened within three months after the closing of the financial year.
4. It shall be convened by the secretary of the trust on behalf of the Governing Council.
5. Notice of the annual meeting of Board of Trustees shall be send to the trustees 15 days prior to the date of the meeting.

- 6. In the General Body Meetings, the decision of the majority of the members present shall be binding on all the members of the trust. In the event of the votes being equally divided, the chairman of the meeting shall have a casting vote.
- 7. Any emergent and urgent business of the trust may be carried out by decisions made after circulation among the Governing Council all the trustees and such decisions shall be ratified in the next meeting of the trustees.
- 8. Extraordinary meeting of the Board of trustees shall be convened by the chairman only on the written request of not less than 2 trustees, after given seven days notice to all the trustees and such a meeting shall be convened within 15 days from the date of receipt of requisition letter by the chairman.

ASSETS OF THE TRUST

The trust assets shall comprise of all funds received as donations whether as corpus fund or otherwise, all income, the investment, movable and immovable properties acquired by gift purchase, lease or otherwise and all the properties shall be held in the name of the trust.

GENERAL

- 1. The trust declared and created hereby is a Public Charitable Trust and is irrevocable.
- 2. The trustees shall have powers to frame time to time rules for the proper conduct of the affairs of the trust and alter, amend any of the powers vested in them for better administration of the trust, herein but they trust.
- 3. The income of the funds of the trust shall be solely utilised towards its objects and no portion of it shall be utilised for the payment to trustees by way of profit, interest, dividend etc.
- 4. No activity of the trust shall be carried outside India.

CYRES

In the event of the trust not being able to function in fulfillment of the objects of the trust after discharging all the liabilities, the trustees shall transfer the assets of the trust to any public charitable institution or institutions having similar objects.





