

SI. No.	The school is directed to ensure that :
1	The total number of sections of Balvatika shall be restricted to 6 (Two each in
	Balvatika 1,2 and 3). The total number of sections from classes 1 to 12 shall be
	restricted to 22, out of which not more than 1/3rd sections may be used for senior
	secondary classes. The optimum number of the students shall be restricted to 40 in
	each section Any further increase of section shall require prior approval of the Board,

	subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	The school showed the Form D of the Building Safety Certificate dated 08.01.2024 valid from 22.01.2024 to 21.01.2027 in the RC video, but failed to upload the same. The Certificate Form A, B, C and D are uploaded in the Mandatory Public Disclosure on the School's Website. The school should submit the same on SARAS portal.
3	The school has submitted an undertaking on Reupload after RC in "Other Uploaded file" that the Boundary wall on one side is under progress and the same will be completed in a months' time. The school should complete the construction of the Boundary wall and submit the compliance with videography within 3 months on SARAS portal.
4	The school should submit the renewed Recognition Certificate on the SARAS portal within 3 months.
5	The school is required to increase the variety of genre of library books like Fictions, non fictions, autobiography, encyclopaedia, self help books, 6 news papers and 10 magazines should be subscribed as per SoPs issued and submit the compliance with videography within 3 months on SARAS portal.
6	Plastic chairs are placed in the Chemistry, Physics and Biology labs which are inappropriate. The school should replace the chairs with wooden stools in the labs. The school should also install Fire Extinguishers and Exhaust fan inside the Labs to prevent safety hazards. Sufficient Wash Basins should be fitted in the Biology lab in the light of SoPs issued by the Board. The school should submit the compliance of the same within 3 months on SARAS portal.
7	The construction of ramp to access upper floors is under progress. The school should complete the construction of ramps to access upper floors and submit the compliance with videography within 3 months on SARAS portal.
8	The school shall conduct training of its teachers with CoE Chennai within 03 months and submit the compliance on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the

- Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
